

## **Customs Regulations**

Customs regulations of the Customs Union (Russia, Kazakhstan, Belarus) are applicable to all foreign nationals.

### **The following goods for private use can be brought to the Customs territory of the Customs Union with custom duty payment relief:**

Goods, the total customs value of which is not over the amount, equivalent to 1,500 Euros, and (or) the total weigh of which doesn't exceed 50 kg;

Alcoholic beverages and beer, max 3 liters per one person older than 18;

Tobacco and tobacco goods: 200 cigarettes or 50 cigars (cigarillos) or 250 g of tobacco, or all the above mentioned goods, the total weight of which is less than 250 g per one person older than 18;

Goods for personal use that are imported by refugees, forced migrants, migrants, as well as one car and one trailer, possessed by such individuals;

Commodities that were inherited, upon condition that there is a documentary confirmation of the fact that these commodities were inherited;

Goods, imported by individuals, who were temporarily staying in a foreign country for min. 1 year (upon condition, that it can be proved with documents); the customs value of the goods must not exceed the equivalent of 5,000 Euros;

Goods, re-imported back to the Customs territory of the Customs Union, in an unchanged state, upon condition that their export from the territory of the Customs Union can be proved with documents;

Funeral urns, coffins with corpses (remains) of the deceased;

### **The following goods are subject to customs declaration:**

Goods the customs value of which exceeds the equivalent of 1,500 Euros and (or) the weight of which exceeds 50 kg;

Cash and/or traveller's cheques exceeding 10,000 (ten thousand) USD;

Monetary instruments (bills of exchange, bank cheques, securities);

Precious metals and jewelry stones;

Government awards of the Russian Federation;

Endangered species of animals and plants, their parts and derivatives;

Weapons and ammunition (upon presenting the appropriate authorization);

Urns with ashes, coffins with bodies (remains) of the dead;

Alcoholic drinks in the amount exceeding 3 liters;  
Narcotic drugs and psychotropic substances in the form of pharmaceutical products for personal use (upon presenting the appropriate documentation);  
Radioelectronics and/or high-frequency appliances of non-military designation;  
Devices with cipher function.

**The following goods for personal use are banned for export:**

Precious metals and jewelry stones the value of which exceeds the equivalent of 25,000 USD;  
Seafood and fish exceeding 5 kg;  
Sturgeon caviar exceeding 250 g.

**The goods for personal use, transportation of which across the Russian Federation border may be permitted by the State Authorities:**

Weapons, their parts, ammunition - Ministry of Internal Affairs of Russia permit;  
Cultural valuables - a permit issued by the government agency that controls the trafficking of cultural property (Ministry of Culture of the Russian Federation);  
Endangered animals, plants and their parts, as well as the products made of them - a permit issued by Federal Service for Supervision of Natural Resource Usage;  
Radioelectronics and/or high-frequency appliances of non-military designation - a permit of the Federal Supervision Agency for Information Technologies and Communications;  
Healthcare products for personal use included into the list approved by the Ministry of Healthcare of the Russian Federation;  
Devices with cipher function - a permit issued by the Center for Licensing, Certification and State Secret Protection of the Federal Security Service of the Russian Federation.
